The prohibited substance Stanozolol was detected in samples obtained from the following greyhounds on the dates listed:-

- Clover Dawn at Waterford Greyhound Stadium on 06/06/2015
- Clover Magic at Waterford Greyhound Stadium on 06/06/2015
- Clover Magic at Waterford Greyhound Stadium on 13/06/15
- Clover Dawn at Enniscorthy Greyhound Stadium on 29/06/2015
- Bigwood Empress at Waterford Greyhound Stadium on 04/07/2015
- Clover Magic at Waterford Greyhound Stadium on 04/07/2015
- Clover Dawn at Waterford Greyhound Stadium on 10/07/2015
- Clover Magic at Waterford Greyhound Stadium on 11/07/2015

OUTCOME

The Control Committee noted the serious nature of the prohibited substance Stanozolol. The Committee was conscious of the fact there were eight cases before the Committee involving three greyhounds which were sampled on multiple occasions over a short period of time during the months of June and July 2015. The Committee, on the basis of the evidence tendered, found all of the eight cases presented were proven.

The Committee noted the circumstances regarding Mr. Delahunty's health and that Mr. Delahunty had no previous offences before the Control Committee. However, in relation to the first case, Clover Dawn at Waterford Greyhound Stadium on the 6^{th} of June, 2015 the Committee decided to impose a fine of €1,500. In relation to the second case, Clover Magic at Waterford Greyhound Stadium on the 6^{th} of June, 2015 the Committee decided to impose a fine of €1,500. Regarding the greyhound Bigwood Empress at Waterford Greyhound Stadium on the 4^{th} of July, 2015 the Committee decided to impose a fine of €1,500. The Committee also found the remaining five cases were proven but did not warrant separate fines as they were taken into consideration in the aforementioned fines imposed. The total prize money of €1,100 won by the greyhounds on the dates in question will also be forfeited.

The Committee also imposed Testing Orders in respect of the greyhounds Clover Magic, Clover Dawn and Bigwood Empress for a period of six months when presented for racing.
