| MATTER | The greyhound Oreo was presented for a Sales Trial at Shelbourne Park Greyhound Stadium on the 19 th of August, 2016. A urine sample obtained from the greyhound on the date in question returned an adverse analytical finding for the prohibited substance Flunixin. Additionally, it was alleged Mr. Michael Cronin was training the greyhound Oreo at the time, in breach of the Greyhound Trainers' Regulations 1961. |
| OUTCOME | Mr. Michael Cronin appeared before the Control Committee. Mr. Pat Herbert, Head of Regulation, Bord na gCon, represented Bord na gCon in this matter. The Control Committee considered all of the evidence tendered and accepted Mr. Michael Cronin's evidence that he was the person in charge of the greyhound at the time. The Committee also accepted Mr. Michael Cronin was not training the greyhound Oreo for reward and therefore, the Committee did not make any finding against Mr. Michael Cronin in respect of the alleged breach of the Greyhound Trainers' Regulations 1961. In relation to the adverse analytical finding for the substance Flunixin in the urine sample obtained from the greyhound Oreo at Shelbourne Park Greyhound Stadium on the 19 th of August, 2016, the Control Committee, having considered all of the evidence tendered, was satisfied the case presented by Bord na gCon was proven. The Committee noted Category 2 meat was fed to the greyhound in an unregulated manner by Mr. Cronin and this could not be attributed to normal and ordinary feeding. The Committee imposed a fine of €250 on Mr. Michael Cronin. |

| OUTCOME | Mr. Mike McKenna was not in attendance and as no communication was received from Mr. McKenna on this matter, the Committee decided to proceed in his absence. Mr. Pat Herbert, Head of Regulation, Bord na gCon, represented Bord na gCon in this matter. |
| | The Control Committee, having considered all of the evidence tendered on this matter, was satisfied the substances Caffeine and Ibuprofen were found to be present in the urine sample obtained from the greyhound Redstone Martial on the date in question. It was a cause of serious concern to the Committee that a combination of two substances, one being a Stimulant and one being a Non-Steroidal Anti-Inflammatory Drug were detected in the urine sample obtained from the greyhound Redstone Martial when presented for racing at Tralee Greyhound Stadium on the date in question. |
| | The Committee noted that Ibuprofen was a human medication not licenced for use in the treatment of canines. The Committee also took into consideration the reported level of Caffeine detected. In the circumstances, the Committee imposed a fine of €1,500 on Mr. McKenna and directed that all greyhounds under Mr. McKenna's care be subjected to sampling, when presented for racing, for a period of six months. Prize money of €235 won by the greyhound Redstone Martial in the race in question is forfeited. |

The Control Committee, having considered the evidence tendered on this matter was satisfied the case presented by Bord na gCon was proven. The Committee noted the substance detected was a human medication not licenced for use in the treatment of canines. The Committee considered this matter to be a serious breach of Regulation and imposed a fine of €1,000 on Mr. O'Hara. The Committee also directed that all greyhounds under Mr. O'Hara's care be subjected to sampling when presented for racing for a period of six months. |
